The CWC shall consist of a Chairperson, and four other members of whom at least one shall be a woman and another, an expert on the matters concerning children.

Applications in the prescribed format are hereby invited from eligible and interested persons for functioning as Chairperson and Members of the CWCs of the seventeen districts viz. Angul, Balasore, Bargarh, Boudh, Deogarh, Dhenkanal, Ganjam, Jagatsinghpur, Kalahandi, Kendrapara, Khurda, Koraput, Malkangiri, Nabarangpur, Nuapada, Sambalpur & Subarnapur whose tenure of three years shall be completed during September 2016.

Applications for the additional CWC for the district of Khurda are also hereby invited for the aforestated purpose.

3. ELIGIBILITY CRITERIA FOR SELECTION OF MEMBER OF CHILD WELFARE COMMITTEE

The eligibility of the applicants shall be in consonance with the stipulations made in the Juvenile Justice (Care and Protection of Children) Act, 2015 under sub sections (4) of section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 and sub rule (4 of (f).ii.(C)) of Rule 24 of the Juvenile Justice (Care and Protection of Children) Odisha Rules, 2002 as amended in 2009 and 2013.

The candidates to be appointed as a member of the Committee shall be a person not less than 35 years of age as on the date of 1st August, 2016.

4. QUALIFICATION AND EXPERIENCE FOR THE MEMBER OF THE CWC:

From amongst the Member of the committee, one at least shall be a woman and another, an expert on the matters concerning children.

No person shall be appointed as a Chairperson or Member of CWC unless such person has been actively involved in health, education or welfare activities pertaining to children for at least seven years **or a** practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human development.

For selection as a Chairperson or Member of the Committee the applicant should have the following qualification in addition to a minimum of <u>seven years experience</u> in their respective fields:

[1] [a] A Post-Graduate Degree in Social Work/ Psychology/ Child Development / Education/ Sociology/ Law / Criminology.

[b] In case of non-availability of applicant with qualification as above, a person with at least a graduate degree in any of the Social Science Disciplines,

[2] A teacher, doctor or a social worker who has been involved in work concerning children;

5. **DISQUALIFICATION:**

P

No person shall be appointed for a period of more than three years as a member of the CWC.
No person shall be considered for selection as a Chairperson or Member of the committee, if he/she:

[a] has a previous conviction record;

[b] has been involved in any immoral act or in an any act of child abuse or employment of child labour;

[c] is holding such full-time occupation that may not allow him/her to give necessary time and attention to the work of the CWC as per the Act and these Rules;

[d] does not fulfil the qualification and experience prescribed in the Act and the rules made there under.

6. PROCESS OF SELECTION:

[1] All the applications received within the stipulated period in the office of the District Child Protection Unit of the District concerned shall be opened by the District Level Screening Committee chaired by the Collector of the District concerned or any other senior officer like ADM / Project Director, DRDA authorised by him in the presence of the applicants or his / her authorised representative, in case, any such applicant or his / her authorised representative, does not turn up, the same shall be opened in absence of the said applicant / representative, in the office of the Collector concerned on

07.09.2016 at 11.00 A.M.

The members of the said Committee may be nominated by the Collector.

[2] The applications so received shall be taken up for scrutiny one after another.

[a] Applications received late or found to be incomplete shall be summarily rejected.

[b] Preliminary scrutiny of all the documents with reference to the conditions of eligibility shall be taken up and thereafter all the documents in original to be produced by the applicant or his / her authorized representative, if present, shall be verified. In case the applicant/his or her authorized representative is found absent for which the District Level Screening Committee would not be able to verify the documents in original, the said application shall be forwarded to the State Level Selection Committee with an endorsement to that effect. Upon such scrutiny all the applications duly classified

as eligible / ineligible as the case may be, shall be forwarded alongwith the Proceedings of the District Level Screening Committee to the Programme Manager, CP, OSCPS.

[3] The State Level Selection Committee shall upon verification of all the cases including "Personal Interview", if required, select the suitable applicants and recommend them for appointment as Member or Chairperson of the Committee, as the case may be, by the Government.

A panel each in respect of the persons to be appointed as Chairperson or Members shall also be drawn up to fill up the subsequent vacancies, arising if any, at any point of time, during the tenure of the CWC by the Government.
