


- All applications received up to 30.11.2016 shall be processed in old software & the beneficiaries shall be paid as per current practice.

Trend analysis of Pending beneficiaries for different instalments










Trend analysis of Pending beneficiaries for different instalments
















Trend analysis of AWW incentives payment












SUBMISSION OF PROPERTY STATEMENT

- ✓ Rule 21 of Government Servant's Conduct Rules, 1959 has been amended in respect of submission of property statement vide GA Deptt. Notification No. 11742 dtd. 13.05.2015, wherein the practice of submission of complete declaration before the end of January at an interval of every three years has been abandoned.
- ✓ As per amended rule, every Govt. servant is required to make a true and complete declaration of all his/her assets movable and immovable in the value thereof as on the 1st March every year in the form given in appendix-A on or before July of that year.
- ✓ A letter was issued to all DSWO & Others vide W&CD Department Letter No. 2595 dtd. 17.02.2016 regarding submission of property statement. In the last DSWO Conference submission of property statement without following due procedure was discussed. The property statement is to be submitted with clear superscription on the envelope "Property Statement for the period from to" with name & address and properly sealed with wax. But the statements are still being received open and without sealed. Since a large number of statements are received incorrect, it is not possible to intimate the position to individual employee. So those who have submitted their property statements incorrect, they are required to comply the discrepancies in the statement individually in the Department.

SUBMISSION OF PAR

- ✓ Online submission of PAR has been made compulsory.
- ✓ Letter has been issued to that effect vide W&CD Department Letter No. 2593 dtd. 17.02.2016. The guidelines in this matter be strictly followed.
- ✓ For wanting CCR prior to 2013-14 promotion cases and RACP cases could not be considered in the DPC / Screening Committee. All DSWOs were requested to communicate the reason of non-recording of CCR / PAR in respect of individual CDPOs for issue of NRC. But reply to that effect is yet to be received. In the meantime another reminder to the concerned DSWOs has been issued to submit CCR of CDPOs whose RACP could not be considered due to want of adequate CCRs vide W&CD Department Letter No. 13585 dtd. 22.08.2016. Early reply to that effect is requested.
