Sub: Commencement of newly created "Department of Social Security and Empowerment of Persons with Disabilities"

- 1) As per decision of the State Government, the newly created "Department of Social Security and Empowerment of Persons with Disabilities" will start functioning with effect from 01.07.2015.
- 2) The new Department will function from the premises of State Institute of Disability Rehabilitation (SIDR), Capital Hospital Campus, Bhubaneswar.
- 3) The new Department will deal with the following subjects.
 - Matters relating to welfare of PwDs
 - Matters relating to Welfare of elderly persons
 - Matters relating to welfare of Trans-genders
 - All social security pensions (NSAP-IGNOAP, IGNWP, IGNDP and Madhu Babu Pension Yojana)

The detailed list of subjects assigned to the new Department as per Odisha Government Rules of Business is given at Annexure-I.

- 4) WCD Department, which is the parent Department of the new Department, will not deal with the above-mentioned subjects after 30.06.2015.
- 5) As decided by the Government, Smt. Usha Devi, Hon'ble Minister(W&CD and P & C Departments) will also function as the Minister of the New Department
- 6) As decided by the Government, the undersigned will function as Commissioner-cum-Secretary of the new Department.
- 7) The employees' cadres of existing WCD Department shall soon be divided between the parent Department and the new Department so that the new Department can have its own State, district and sub-district level employees. Till that time, activities of the new Department shall be implemented and monitored by the WCD Department employees as is the case now.
- 8) Since the new Department will have its own Budget Head from next financial year, all budgetary matters pertaining to the new Department for this financial year shall be done under the approved Budget of WCD Department.
