In pursuance of the provisions contained under section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015 read with rules 3 and 88 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016, and in continuation of Notice No. 1134 Dated 12.08.2016 issued by the Odisha State Child Protection Society (OSCPS), applications in the prescribed format are hereby invited from eligible and intending applicants for the position of Members of the Juvenile Justice Board (in short "JJB") in respect of all the districts of Odisha.

The details of eligibility criteria, other conditions and format for application are available in the website of this Department, (<http://www.wcdodisha.gov.in>) and that of the Odisha State Child Protection Society (www.oscps.nic.in) which may be accessed /downloaded.

Applications in the format prescribed along with self-attested copies of relevant certificates/documents etc. kept in a **sealed cover superscribed with the words " Application for selection as members of the Juvenile Justice Board"** may be sent to the office of the District Child Protection Unit of the District concerned during the office hours on any working day **on or before 18th December, 2017 by 5:00 P.M.** through **Speed Post / Regd. Post** or may be dropped in the Drop Box kept for the purpose in the said office.

Those persons, who have already applied, pursuant to the Notice No. 1134 Dated 12.08.2016 as aforesaid need not apply again.

DETAILED INSTRUCTIONS FOR SELECTION OF APPLICANTS AS MEMBER OF
THE JUVENILE JUSTICE BOARDS

Sub-section (1) of section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015 [2 of 2016] read with rules 3 and 88 of the Juvenile Justice (Care and Protection of Children) Model Rules, 2016 provide for constitution of a "Juvenile Justice Board" for each district and selection of Members of the said JJB for the purpose of which applications are hereby invited from the eligible and interested applicants in the manner delineated below in respect of the districts as mentioned in the Notice.

2. CHECKLIST OF DOCUMENTS:

3. EXPERIENCE, QUALIFICATION, AGE AND CRITERIA FOR THE MEMBER OF THE JJB :

For appointment as Member of the JJB, the applicant should have been :

- (1) (A) Actively involved in health, education, or welfare activities pertaining to children for at least seven years; or
(B) A practicing professional with a degree in child psychology, psychiatry, sociology or law;
- (2) The candidates to be appointed as aforesaid shall be not less than 35 years of age as on the date of 1st November, 2017.
- (3) One of the Members of the JJB shall be a woman.
- (4) A Member selected by the Selection Committee **should not** :
 - (A) be holding such full time occupation that may not allow the person to give necessary time and attention to the work of the JJB as per the provisions of the Act and the Rules;
 - (B) be associated with any Child Care Institution, directly or indirectly, during his tenure as the Member of the JJB or have any other conflict of interest,
 - (C) hold any office in any Political Party during his tenure, or
 - (D) be insolvent
- (5) A Member of the JJB shall be eligible for appointment of maximum of two terms, which shall not be continuous.
- (6) No person shall be eligible for selection as Member of the JJB if, she/he ;
 - (i) has any past record of violation of human rights or child rights;
 - (ii) has been convicted of an offence involving moral turpitude and such conviction has not been reversed or has not been granted full pardon in respect of such offence;

(iii) has been removed dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;

(iv) have ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.

4. PROCESS OF SELECTION:

[1] All the applications received within the stipulated period in the office of the District Child Protection Unit of the District concerned shall be opened by the District Level Screening Committee having members nominated by the Collector and chaired by the Collector of the District concerned or any other senior officer like ADM / Project Director, DRDA authorized by the Collector, in presence of the applicants or her / his authorized representative.

In case, any such applicant or her / his authorized representative, does not turn up, the same shall be opened in absence of the said applicant / representative, in the office of the Collector concerned on **19.12.2017 at 11.00 A.M.**

[2] The applications so received shall be taken up for scrutiny one after another.

[a] Applications received **late** or found to be **incomplete** shall be kept separately , duly listed.

[b] Preliminary scrutiny of all the documents with reference to the conditions of eligibility shall be taken up and thereafter all the documents in original shall be verified with the photocopies of which have been attached to the application form on being produced by the applicant or her / his authorized representative, if present,

[c] In case the applicant or her / his authorized representative is found absent for which the District Level Screening Committee would not be able to verify the documents in original, the said application shall be forwarded to the State Level Selection Committee with an endorsement to that effect.

[d] Upon such scrutiny, all the applications duly sorted, shall be forwarded along with the Proceedings of the District Level Screening Committee to the Director, OSCPS.

[3] The State Level Selection Committee shall evaluate the candidates on the basis of qualifications, experience of working with children and personal interaction with the applicant.

[4] The State Level Selection Committee shall, on the basis of the evaluation procedure and criteria, select and recommend a panel of names for the position of the Members in order of merit to the State Government for appointment as Members of the JJB to fill up the subsequent vacancies arising if any.
