- 2. The appointment of any member of the Committee shall be terminated by the State Government after making an inquiry, as stipulated under sub-section (7) of section 27 of the Act, if—
 - (i) he/she has been found guilty of misuse of power vested on him/her under the Act;
 - (ii) he/she has been convicted of an offence involving moral turpitude and such conviction has not been reversed or he/she has not been granted full pardon in respect of such offence;
 - (iii) he/she fails to attend the proceedings of the Committee consecutively for three months without any valid reason or he/she fails to attend less than threefourths of the sittings in a year.
- 3. The Committee shall function as a Bench and shall have the powers conferred by the Code of Criminal Procedure, 1973 (2 of 1974) on a Judicial Magistrate of First Class.
- 4. The Committee shall meet at least twenty days in a month and shall observe such rules and procedures with regard to the transaction of business at its meetings, as prescribed.
- 5. Notification No. 14520, dated 23.08.2018 relating to the constitution of Child Welfare Committee in respect of Subarnapur district is hereby modified to this extent.
- 6. Tenure of the CWC will remain the same as mentioned in Notification No. 14520, dated 23.08.2018.
