Sub: Clarification on the eligibility criteria for upgradation of mini AWWs to main AWWs during upgradation of 7579 mini AWCs to main AWCs.

Ref: This department letter no. 5779 dated 11.03.2024

Madam,

With reference to the subject cited above, I am directed to inform you that as per the letter No.5779/WCD dtd.11.03.2024 for upgradation of mini AWCs to main AWCs, the following eligibility criteria for mini AWWs are to be followed :

- a. All the 7579 mini AWWs are to be upgraded to AWWs with their existing educational qualifications as they must have been engaged following the guidelines which were prevailing then. The educational qualification of +2 or 12th standard is not mandatory.
- b. Further, the current revised honorarium of Rs.10,000/- per month and 5000/- per month will be provided to AWWs and AWHs respectively of these upgraded 7579 AWCs.

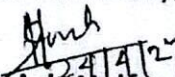
Sir,

In inviting reference to the subject cited above I would like to request you that a clarification may kindly be given on the following points of the letter no-5779 dtd-11.03.2024 for up-gradation of 7579 Mini-AWC to Main-AWCs.

In Para point no-3 it is mentioned that henceforth 7579 mini AWWs as per the list enclosed shall work as Anganwadi Workers with honorarium @ Rs-7500/- per Anganwadi Workers if they fulfill the eligibility criteria. Hence a clarification on eligibility criteria may kindly be provided in respect to the existing qualification or +2 qualifications is mandatory, as per previous guideline issued by the department, for taking necessary steps at our end at the earliest.
