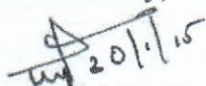
Madam/Sir,

In inviting a reference on the subject cited above, I am directed to say that Mamata benefit will be provided to all expectant mothers of the PVTG community residing in the Micro Project areas irrespective of their birth order under the Convergent Action plan for PVTGs and the recently launched Odisha State Policy for Girls and Women. The benefits under the scheme will be provided for an initial period of 5(five) years.

In this regard, the Special Officers of the Micro Projects have been requested to provide the list of PVTG individuals residing in the Micro Project area to the concerned Child Development Project Officers (CDPOs) vide letter No. 33904, Dt.22.12.2014 of ST & SC Department. The CDPOs will share the list of individuals with the respective AWCs. This will enable the AWWs in registering the expectant mothers from the PVTGs and extending the benefits under the scheme.

You are therefore, requested to ensure that the list of beneficiaries is shared with the concerned CDPOs and necessary steps are taken at the AWCs for identifying the potential beneficiaries. This may be treated as urgent.
