Sub: Registration and payment to MAMATA beneficiaries through new MAMATA MIS.

Madam/Sir,

In inviting a reference to the subject cited above, I am directed to say that the department have developed a new MIS for direct bulk transfer of funds through iFMS to the accounts of MAMATA beneficiaries. In this platform fund transfer to beneficiaries will be made centrally through iFMS once in a week.

You and all the CDPOs are already trained on use of MIS. Development of mobile app is also complete. If any Supervisor, AWW is using smart phone, she can use the mobile app for processing claims.


Since the MIS is completed in all respect, it is decided by the government that all new beneficiaries are to be registered through the MIS only from 1st of August, 2020. Similarly, all first installment of the benefit due for release on or after 01.08.2020 shall also be made through newly developed MIS only and not through SBI platform.

Again, all 2nd installment due on or after 15.08.2020 shall also be made through the MIS only. All old data of MAMATA will also be integrated in the new MIS over the period of time. Therefore, pregnant women survey (till June 2020) and MAMATA Tracker (till 31.07.2020) should be sent to the department by 05.08.2020.

You are therefore, requested to ensure that all CDPOs uses new MIS in strict compliance to the instructions issued as above. Any deviation would be seen adversely.
