In inviting a reference to the subject noted above, I am directed to say that there are total 11,245 nos. of approved beneficiaries who are yet to receive the SUBHADRA benefits due to failure at Bank /NPCI level arising out of certain discrepancies in their bank accounts like invalid Aadhaar, frozen/ closed bank account, etc

In view of this, the District/ ULB/ Block/ GP/ Ward wise failed transaction list along with the reason mentioned against the names has been mailed for your kind reference and necessary action at your end. Besides, the concerned Officials at your level can also download the said list using the user ID shared through your official mail IDs as well.

Therefore, you are requested to engage field level Officials like Anganwadi Workers/ Bank Mitras/ MBKs etc. to reach out to the concerned beneficiaries for rectification of their discrepancies early for successful transfer of SUBHADRA benefits to their accounts. The LDM may also be assigned the task to review it regularly and ensure full cooperation from the banks.
