NOTIFICATION

The 22nd March 2018

No. 4700—WCDMS-FE-PEN-0150/2016-WCDMS—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules to amend the Odisha Social Welfare Service, Group-B (Method of Recruitment and Conditions of Service) Rules, 2002, namely :—

1. Short title and commencement—

(1) These rules may be called “the Odisha Social Welfare Service, Group-B (Method of Recruitment and Conditions of Service) Amendment Rules, 2017.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Orissa Social Welfare Service, Group-B (Method of Recruitment and Conditions of Service) Rules, 2002, (hereinafter referred to as the said rules), for word “Orissa” wherever it occurs, the word “Odisha” shall be substituted.

3. In the said rules in Rule 2, in sub-rule (1), for Clause (a), the following clause shall be substituted, namely :—

“Assistant District Social Welfare Officer” means Assistant District Social Welfare Officer posted in the district on promotion from the post of Statistical Assistant.

4. In the said rules in Rule 3 for the words “State Institute of Rural Development”, the words “Middle Level Training Centre” shall be substituted.

5. In the said rules, in Rule 4,

(a) for sub-rule (1), the following sub-rule shall be substituted, namely :—

“(1) Recruitment to the service shall be made by the Government on the basis of selection from among the Assistant District Social Welfare Officers and Child Development Project Officers in the ratio of 1:15 basis.” :

- (b) In sub-rule (2), the words "Subdivisional Social Welfare Officers" appearing after the words "Assistant District Social Welfare Officers" shall be omitted.
6. In the said rules, in Rule 6, in sub-rule (2) and sub-rule (3), the words "Subdivisional Social Welfare Officers" appearing after the words "Assistant District Social Welfare Officers" shall be omitted.
 7. In the said rules, in Rule 7, in Clauses (ii) and (iii) the words " Subdivisional Social Welfare Officers" appearing after the words "Assistant District Social Welfare Officer" shall be omitted.
 8. In the said rules, in the provisio to Rule 9, the words " Subdivisional Social Welfare Officers" appearing after the words "Assistant District Social Welfare Officers" shall be omitted.
 9. In the said rules, in the Rule 10, for sub-rule (1) the following shall be substituted, namely :—
" (1) Appointment to the service shall be made in the order in which the names of officers appear in the select list in the ratio of 1:15 basis."
 10. In the said rules, the Annexure appended to these rules shall be deleted.
