RESOLUTION

The regularization of the ICDS Contractual Supervisors who were selected from amongst Anganwadi workers having 5 years of experience with graduate qualification was under active consideration of the Government from some time in the past. Now after careful consideration, the Government have been pleased to regularize the services of Contractual ICDS Supervisors working in different ICDS projects by creating equal numbers of temporary posts in Level-9 in order to absorb the Contractual ICDS Supervisors till their superannuation as per FDOM No. 18117/F, dtd 16.4.1970.

2. The post so created is personal to the employee for whom it is created and no other employee can be appointed against such post. It would stand abolished as soon as the employee for whom it is created vacates it, on account of retirement or confirmation in another regular permanent post or for any other reason. The above ICDS Supervisors are to be placed at the bottom of the gradation list of ICDS Supervisors in their district as on date. The service and financial benefits will accordingly flow prospectively.

3. The salary and other allowances of the Supervisors will be drawn from the budget head 36-2235-02-102-3259-01003.

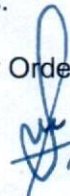
4. This has been concurred in by Finance Department in their File No. FIN-SOS3-ESTT-0006-2019.

5. This has been approved by the State Cabinet in its 75th Meeting held on 29.02.2024.

6. This will come into force from the date of issue of this Resolution.

7. The post of Lady Supervisor is a district Cadre post. Hence, the Collectors concerned will issue the order of regularisation of services of such ICDS supervisors belonging to their districts by creating equal number of temporary posts.

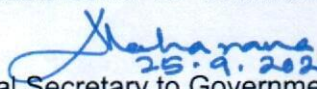
