Sub: Clarification on selection of Anganwadi Helper for the post of Anganwadi worker in the same AWC.

Madam/ Sir,

In inviting a reference on the subject & letter cited above, regarding AWH's engagement as an AWW in the same AWC, subject to vacancy, I am directed to provide a clarification that you must abide by the instructions provided in para 4 and 4(a) of the guideline communicated vide this Department Letter No. 4970 dated 15.03.2023.


Further, if the AWH of that specific AWC meets the following requirements:

- a) Has the requisite qualification and is found to be suitable for the post of AWW
- b) Has worked for more than five years in the same AWC

then no open advertisement or selection process needs to be conducted to fill the vacancy of AWW in the relevant AWC and preference will be given to AWH.


Sub-Sir,
