**CORRIGENDUM WITH REGARD TO APPLICATION FOR SELECTION AS MEMBERS OF
THE JUVENILE JUSTICE BOARDS**

In pursuance to this Department Notice No. 26521, Dated 16.10.2025, regarding application for selection as members of Juvenile Justice Boards, the **last date for submission of the application** is hereby extended till **15.01.2026 by 5.00 PM** with modified required experience and qualification criteria.

The following changes are made in the earlier notice.

1. Submission of Application: Educational Qualification & Experience:

xxxxx the para [1(12.ii)] xxxxx "is a practicing professional in child psychology or Psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children" xxxxx shall be **substituted and read as** "shall have at least seven years of experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law". xxxx

2. Experience, Qualification, Age and other criteria for the member of the Juvenile Justice Boards.

xxxxxx the para [3(1)] xxxxx "shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children" shall be **substituted and read as** "shall have at least seven years of experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law".xxxx

3. Process of Selection

In the Para - 4 (1) of aforesaid Notice, the date mentioned as 11.11.2025 may be read as **23.01.2026**.

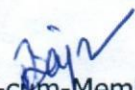
Upon the extension of the last date for submission of the applications, accordingly the last date may be read as 15.01.2026 in the detailed instruction for selection of applicants as member of the Juvenile Justice Boards and tentative schedule has been modified as follows:

3.	27 .01.2026	SUBMISSION OF APPLICATIONS BY THE DCPUs TO THE DIRECTOR, OSCPS

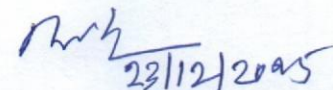
5. The candidates who have already submitted applications in response to the earlier notice need not apply again.

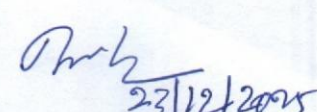
