


CLARIFICATION OF THE PRE BID QUERIES RAISED BY BIDDERS


IN THE PRE-BID MEETING

The Pre-Bid Meeting of the Tender Notice No-61/MVSN dt.19.01.2026, 62/MVSN dt.19.01.2026, 63/MVSN dt.20.01.2026, 64/MVSN dt.20.01.2026 was held at W&CD Complex, Ganganagar, Bhubaneswar on 27.01.2026 in presence of the Members of the Tender Committee and the authorized representative of the Bidders. The clarifications for the respective queries received by MVSN on or before 27.01.2026 are as follows.

1	Do we have to attach a single purchase order exceeding Rs. 30.00 Lakh in any of the 3 financial year with an organisation? Or Aggregate of small purchase orders exceeding 30.00 Lakh in any of the 3 financial years or an aggregate of small purchase orders exceeding 30.00 Lakh in all the three financial year.	The bidder must attach a single purchase order of minimum order value of Rs. 30.00 Lakh in each of the last three financial years of 22-23, 23-24 and 24-25.

The delivery point of the item is at Mahila Vikas Samabaya Nigam, W&CD Complex, Ganganagar, Unit-6, Bhubaneswar.</p> <p>ii. Yes, printed samples are to be submitted at the office of MVSN on or before the bid due date.</p> <p>iii. The bidder shall have minimum 3 years of post-incorporation experience in executing the "similar work" for which the bid is to be submitted.</p>


	iv. Aggregate L1 will be taken for registers and takeaways or individually	iv. L1 bidder for Laminated Takeaway and Registers will be evaluated separately as per the rate quoted in the financial bid.
3	As per Procurement policy, the criteria for past experience and turnover are relaxed for start-ups and MSEs. We request clarifications whether eligible Start-ups and MSEs can avail this relaxation for these tenders (Tender No. 62 and 63), similar to EMD exemption being allowed.	With reference to the query regarding relaxation of criteria for Past Experience, Turnover and EMD Exemption, Start-ups and MSEs under Tender No. 62 and 63, it is clarified that the request has been duly examined and taken into consideration. Accordingly, MSEs and Start-ups shall be allowed relaxation, as per the applicable provisions/norms of the Government of Odisha.
4	Whether we can participate or not participate in any government tender process but successfully supplied big orders under private sector having turnover of rupees more than 1 Crore.	It is clarified that the eligibility conditions of the existing tender requires the bidder to have successfully completed required supply orders during the last three (03) financial years, executed under any State / Central Government Department, PSU, or Government-aided organization.
