NOTIFICATION

In supersession of all the previous Notification relating to constitution of the Child Welfare Committee of Khurdha and Sundargarh district and in pursuance of the provisions contained under Section 27 of the Juvenile Justice (Care and Protection of Children) Act, 2015 [hereinafter referred to as "the Act"] read with Rule 22 of the Odisha Juvenile Justice (Care and Protection of Children) Rules, 2018 and Section 9 of the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021, the Child Welfare Committee of the following districts is hereby constituted for exercising the powers and to discharge the duties conferred on such Committee in relation to children in need of care and protection as prescribed under the Act and the Rules framed thereunder with immediate effect for a period of three years.

2. The appointment of any member of the Committee shall be terminated by the State Government after making an inquiry, as stipulated under sub-section (7) of section 27 of the Act, if—

- (i) he/she has been found guilty of misuse of power vested on him/her under the Act;
- (ii) he/she has been convicted of an offence involving moral turpitude and such conviction has not been reversed or he/she has not been granted full pardon in respect of such offence;
- (iii) he/she fails to attend the proceedings of the Committee consecutively for three months without any valid reason or he/she fails to attend minimum three-fourths of the sittings in a year.

3. The Committee shall function as a Bench and shall have the powers conferred by the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023) (BNSS) on a Judicial Magistrate of First Class.

4. The Committee shall meet at least twenty days in a month and shall observe such rules and procedures with regard to the transaction of business at its meetings, as prescribed.




